RESOLUTION NO. 2011-02

A RESOLUTION APPROVING A SETTLEMENT AGREEMENT AND GENERAL RELEASE WITH MARTHA S. PAIGE TO SETTLE AND RELEASE ALL CLAIMS AGAINST THE WARREN COUNTY PORT AUTHORITY CONTAINED IN CASE NUMBER 1:08CV518, CAPTIONED MARTHA S. PAIGE V. KIMBERLY COYNER ET AL.

WHEREAS, on August 8, 2008, Martha S. Paige ("Paige" and, together with the Authority, the "Parties") initiated litigation against the Authority in the Southern District of Ohio, Western Division, captioned Martha S. Paige v. Kimberly Coyner et al., Case No. 1:08CV518 (the "Lawsuit");

WHEREAS, the Parties desire to forever settle and resolve all of the claims, disputes, and controversies between them pursuant to a Settlement Agreement and General Release (the "Release"); and

WHEREAS, pursuant to the Release, Paige will agree to dismiss with prejudice her pending claims against the Authority that are set forth in the Lawsuit, but this dismissal shall not apply to Paige's pending claims against other parties named in the Lawsuit;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE WARREN COUNTY PORT AUTHORITY THAT:

The Release in the form now on file with the Board is hereby approved, and the Authority is authorized to pay to all amounts contained in the Release, which amounts are expected to total \$21,000.00. The Executive Director of the Authority (the "Executive Director") or any other officer of the Authority is authorized to execute and deliver the Release on behalf of the Authority with such changes therein that are not substantially adverse to the Authority. The approval of those changes, and that such changes are not substantially adverse to the Authority, shall be conclusively evidenced by the execution of the Release by the Executive Director or any other officer of the Authority.

Section 2. It is found and determined that all formal actions of this Authority concerning and relating to the adoption of this Resolution were taken and adopted in an open meeting of this Authority, and that all deliberations of this Authority that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code.

Section 3. This Resolution shall be in full force and effect immediately upon its adoption.
